1. \_\_\_\_ The adopter agrees and binds him/herself to take good and responsible care of the dog, feed, fully obedience train, house the dog properly, control the dog on lead when off premises and to house and control the dog properly to avoid loss by theft, running away, or otherwise, and to properly give or secure the best attention to the physical welfare of the dog. If adopter fails to do so Bullie Pups R Us has the right to reclaim said dog at the adopters expense.

2. \_\_\_\_\_ The adopter has the financial resources to pay for proper veterinary care for the dog adopted through Bullie Pups R Us. All puppies must have a veterinary health insurance policy in effect for their puppy with an effective date equal to the date the puppy arrives at its new home. A copy of this policy must be sent to BPRU before shipment of your puppy or this may cause delay in your puppy's arrival. Policy must stay in effect for thirty days after the puppy leaves our possession. Purchaser must follow all Veterinarian guidelines for vaccination and worming schedules.
3. \_\_\_\_\_ The adopters will receive a veterinary certificate and a medical record certifying that their dog is in good health and has been given proper care by a licensed veterinarian. A "Guarantee of Good Health" may also be given in lieu of the veterinary certificate.
4. \_\_\_\_\_ The adopter understands that the delivery date may be changed at any time if the dog needs additional veterinary care before it can be shipped. BPRU, LLC is not liable for delays due to weather or other complications when shipping. I the buyer understand that responsible ownership begins with taking your puppies welfare into first priority. This starts with us determining the proper the age, circumstances and time the new puppy is shipped safely to his new home. Not all puppies develop at the same rate and some may take longer than others for this process.
5. \_\_\_\_\_ BPRU, LLC will grant all its dogs with full breeding rights unless otherwise specified. If the dog is unable to breed or be bred for ANY reason, BPRU, LLC is not responsible or liable in any way, as we do not place dogs for the sole purpose of breeding. If a dog is listed as show potential, this means it has the potential to show but does not guarantee it. It is impossible to determine show quality in any puppy under the age of 12 months. This is why it's listed as show "potential". A puppy can develop any undesirable show or breedable traits until it is one year of age. If you wish to have a show "quality" dog we suggest buying a dog at the age of 12 months or older.
6. \_\_\_\_\_ The adopter agrees that they will have the dog examined by a licensed veterinarian within 3 business days of receiving it. If the dog is found to have any illness, hereditary or congenital defect covered in this contract it is the responsibility of the adopter to notify BPRU, LLC within 2 business days of exam, along with a required document from the veterinarian stating the condition, set forth in separate cover to BPRU, LLC. This must be done within 48 hours from the appt.
- 7 \_\_\_\_\_ Adopter agrees NOT to use the above described dog for crossbreeding or dog fighting, nor is this dog or any of its offspring to be sold to any pet store or wholesale dog establishment If this dog is used for these purposes BPRU, LLC has the right to reclaim the dog from the adopter at the adopter's expense with no compensation due to adopter for the dog.

8. \_\_\_\_\_ If the adopter decides to cancel their transaction before the arrival of said puppy but after the adoption and payment is made all monies will be forfeited or used as a full credit for another puppy within 6 months from the original adoption date. It is understood that **NO REFUNDS in part or in full** will be given for personal conflicts/ or change of heart. The money can be used as a credit towards another puppy within 6 months from the date of the original adoption. If you have clicked on the BUY paw and submitted your credit card information on the website you have contractually adopted a puppy and your credit card will be charged unless the puppy was currently pending adoption with another customer. **NO REFUNDS in part or in full under any circumstance, full store credit will be given only.**

9. \_\_\_\_\_ If the dog above is examined by a licensed Veterinarian within the first 120 days of age of and found to have an untreatable, life threatening, genetic or congenital defect that would render the pet to be crippled or be due cause for euthanasia, or cause death the buyer has the option of **returning** the dog at adopters expense for a 100% credit toward another puppy from Bullie Pups R Us. If a puppy dies from a genetic or hereditary defect, a necropsy and full report will be needed and sent to Bullie Pups R Us. There are **NO REFUNDS in part or in full** only replacements puppies will be given. The following items are a few examples of conditions not covered in the untreatable, life threatening congenital and hereditary health guarantee. Mange, cherry eye, entropion, "loose" hips, skin allergies, coccidia, internal parasites, bacterial or viral illnesses, reducible umbilical hernias, general allergies or cilia disorders. In addition any puppy adopted for a fee less than \$1500.00, not including shipping, will be adopted as-is with no health guarantee), or export pedigree. All puppies given replacement under this guarantee will not be accompanied by an export pedigree. If the export pedigree has been sent all papers will need to be returned and signed over to Bullie Pups R Us.

10. \_\_\_\_\_ If the dog above is examined by a licensed Veterinarian after 120 days of age to 365 days of age and found to have an **untreatable**, life threatening, genetic or congenital defect that would render the pet to be crippled or be due cause for euthanasia, or a **direct** cause of death then BPRU, LLC will give a 50% discount off a replacement puppy of their choice, not to exceed the purchase price of their original puppy. The dog named above will have a warranty for officially declared and veterinarian documented, hereditary or congenital defects directly causing death from the age 366 days to age 730 days old and will be due cause for the purchaser to have a 20% discount for a replacement puppy of their choice, not to exceed the purchase price of their original puppy. All full necropsy report will be required in all cases. All puppies given replacement under this guarantee will not be accompanied by an export pedigree. If the export pedigree has been sent all papers will need to be returned and signed over to BPRU, LLC for your discount or replacement. Females are not guaranteed past the timeframe of any confirmed pregnancy under any circumstance!

11. \_\_\_\_\_ Adopter guarantees that this is not an impulse decision. Thought has been given into this adoption regarding schedules, needs of the dog, and needs of the family, and financial obligations. The adopter has carefully researched the extensive health problems that may arise with the breed and understands that dog ownership is a responsibility and may require medical expenses for maintenance and health conditions in the future. English Bulldogs are a breed that can be a high maintenance breed at times and need to be indoor dogs only. Careful consideration has been given to the adoption of this puppy for all purposes. It is understood that **NO REFUNDS in part or in full** will be given for personal conflicts/ or change of heart. Only full store credit will be given to the buyer to be used within 6 months from the original date of purchase.

12. \_\_\_\_\_ It is understood that THIS EXTENDED HEALTH GUARANTEE IS NULL AND VOID AND WILL NOT BE HONORED BY BPRU, LLC IF THE ABOVE-MENTIONED DOG IS USED FOR BREEDING BEFORE A CLAIM IS MADE ON THE GUARANTEE. If the above-described dog produces a litter or is used for stud before 365 days from birth then the replacement terms no longer apply and are null and void. Females are not guaranteed past the time of any confirmed pregnancy under any circumstance!

13. \_\_\_\_\_ BPRU, LLC retains the Right of First Refusal should the adopter decide to give away or sell the dog for whatever reason. If this option is not properly executed the adopter will face fines up to the purchase price of the puppy and any legal fees involved. This is in place to avoid the placement of any of my puppies in animal shelters, or any other unfavorable situations. Bullie Pups R Us will help in placing your puppy or dog when possible. Failure to comply with this will be due cause for legal action by BPRU, LLC.

14. \_\_\_\_\_ BPRU, LLC guarantees that the above-described dog is a purebred English Bulldog that will be issued with a copy of an official export pedigree. If buyer wants registration papers for their pet it is their option to do so and their responsibility solely to obtain, as we are not related to any third party registries. **We do not provide registration papers to any registry only export pedigrees.** BPRU, LLC is not responsible for any decisions or actions made by any third party registry in transferring the registration of your puppy.

15. \_\_\_\_\_BPRU, LLC guarantees that all adopters will receive a copy of an official export pedigree on adopted pups within 12 months from the date of purchase. In majority of cases the export pedigree will not arrive with your puppy at the time of pick up. Adopter agrees to **read this paragraph TWICE** before signing to avoid confusion and unneeded stress or worry at the time their puppy arrives. The reason for the delay in the export pedigree can be due to the registry the puppy is registered with, mail, work backlog and the fact that export pedigrees are not given on puppies that have been replaced under the 12-month health guarantee. **Please do not contact BPRU LLC in regards to an export pedigree prior to 10 months from date of adoption.**

16. \_\_\_\_\_ BPRU, LLC is not responsible for any Veterinarian care authorized by the adopter or any of its family members for the above-mentioned dog after it has arrived at its new home. All Veterinarian charges incurred after shipping of the puppy to its new home are the adopter's responsibility solely unless approved in advance by BPRU, LLC.

17. \_\_\_\_\_ Adopter understands all puppies ship **direct to the buyer from the breeder** and agrees that if the puppy is imported that a CDC form will be filled out by the adopter and will adhere to the requirements enforced by the Health Department and Center for Disease control and will confine the dog from the general public as best as possible until 30 days after its rabies vaccination and will take responsibility and sole liability for not doing so if the puppy would bite a human being during that timeframe. BPRU, LLC will not be held liable or responsible if the adopter fails to comply with any of these Federal Laws.

18. \_\_\_\_\_ Adopter understands that the total adoption price includes shipping. The actual purchase price of the puppy and shipping will be broken down on your receipt. Shipping expenses are in addition to the adoption price of the puppy but included in the total price advertised. Shipping is provided and arranged as a courtesy by a third party and Bullie Pups R Us is not responsible for any damages to your puppy while in transit. All puppies will be insured for the value of replacement while in transit. Monies tendered to the shipper/airline on behalf of the adopter, shown on the receipt signed by the buyer, are **nonrefundable** by BPRU, LLC once the puppy has been shipped. Transportation is arranged through third party carriers and frequently there are delays for numerous reasons including but not limited to weather, logistics, mechanical failure or other unforeseen events. Thus, BPRU, LLC shall not be responsible or liable directly or indirectly for any delays that may cause you inconvenience or financial loss.

Any expenses incurred having to defend this clause in any jurisdiction other than stated above will be at the buyer's expense. This contract is not valid outside the United States, nor is the contract, or the guarantee herein assignable.
